

## EMS Certification Continuing Education Renewal Requirements:

The following is a summary that will help answer questions about meeting the requirements for maintaining an EMT certification in Ohio. Although every attempt has been made to ensure the accuracy of the following information, in the event of a discrepancy, the language in the Ohio Administrative Code 4765-8 shall apply. 	<b>The CE hours requirement is calculated based on how long the certificate was active during certification cycle (the number of months between the effective date and the expiration date):</b>
