\* An extension has been granted for submission of 2020 first and second quarter trauma records for all Ohio hospitals, free-standing emergency departments, trauma regions, and trauma registrars required to report to the Ohio Trauma Registry:

- 2020 First and Second Quarter Trauma Records for patients discharged from January 1 through June 30, 2020, will now be **due by December 31, 2020.**

- 2020 Third Quarter Trauma Records for patients discharged from July 1 through September 30, 2020, will remain unaffected and are also due by December 31, 2020.
